EVISA- The validity of e-Tourist Visa and e-Business Visa will be one year from the date of grant of ETA. Multiple entries will be permitted on e-Tourist Visa and e-Business visa. Varies by nationality.

In case of e-Conference visa, validity will be 30 days from the date of arrival in India. Only single entry is permitted on e-Conference visa. In case of e-Medical and e-Medical Attendant visas, validity will be 60 days from the date of first arrival in India. Triple entry will be permitted on e-Medical and e-Medical Attendant visas.
